### Usage Rules and Acknowledgements:

*Applicants must provide license plate number and either a picture of the RV or registration. If not, RV spot will not be assigned to the applicant until information is provided.	Initial:
* In order to transfer to a different yard tenant must fill out Intent to Vacate RV form.	
* When applicant is no longer in need of assigned RV Storage spot they will need to fill out an Intent to Vacate RV form.	
*Effective 10/24/2019, applicants who sign up for RV Storage and are placed on the waiting list are <u>not</u> permitted to park in the Morenci/Clifton Townsite area while on the waiting list. All items must be stored outside of the Townsite.	
*"RV" = Flatbed trailer, boat, motorhome, Recreational Vehicle, Toy Hauler, etc.	
*As stated on all Tenant's Residential Lease on page 3: <i>No motorhomes, trailers or boats exceeding ten (10') feet in length may be stored on the premises. Any vehicles found to be in violation of these requirements are subject to removal.</i>	
*Always close and lock the gate when entering and exiting the RV Storage Facility.	
*Park only in your designated space. Unauthorized parking may result in towing.	
*Vehicles, 4wheelers, side by sides, etc. are not permitted to park in the RV Storage Facilities unless they are placed on a trailer.	
*Be respectful of others property and assigned spaces.	
*Contact Housing for key replacements. Lost keys may result in a replacement charge.	
*It is not permitted to lend your key to others or allow others to park their RV in your space.	
*Only park in your assigned parking place. If someone else has parked in your assigned RV space, do not park in another person's spot. Please take a picture of the RV and license plate and let Housing know.	

*You are able to have your RV parked at your house 1-3 days before and after taking it out to clean, load/unload, and prepare for your trip. Please call Housing to give us the dates when it will be parked at your house.	Initial:
*Notify Housing if you purchase a new RV, get new license plates, or if any of the items in your parking space have changed.	
*Items must be kept in mobile condition at all times with tires inflated. Keep area tidy and clear of trash.	
*RV Storage is only for Freeport Tenants, not those on the waiting list or who live outside of the Morenci Townsite.	
*RV assignments are only for the specific RV on your application. If you sell your current RV and need a new spot, please notify Housing and fill out a new application for the new RV.	
*The RV parking area and the Morenci Townsite are routinely inspected to ensure compliance with the above mentioned rules and acknowledgements. Failure to adhere to these rules can result in the loss of your storage space privilege and RVs being towed.	
*RV spaces must be used. Periodic inspections take place and if found that your spot is not being used, you will be notified to contact the Housing office. If we do not hear from you by the due date, your spot will be reassigned to another person on the waiting list.	
*If spot will be vacant for longer than 2 weeks – must fill out form with Housing to note when RV will be removed from your reserved RV space and when it will be returned. An inspection will take place once it is returned to ensure the spot is being used again. Update Housing should the dates change.	
*The RV Storage Facility is considered company property and is subject to all rules, policies, and guidelines associated with company parking areas. This includes company policy prohibiting drugs, alcohol, and/or firearms.	
*Policies are subject to change. Please retain copy for your records.	
*By signing up for RV Storage and signing this agreement, you are hereby agreeing to follow all of the procedures mentioned on this sheet.	
*Freeport-McMoran Morenci Inc. is not responsible or liable for any damage to or theft of your RV/Vehicle that may occur while your vehicle is on property owned, leased or controlled by Freeport-McMoran Morenci Inc. or any of its subsidiaries.	
*Effective 2/1/21 All applicants must have RV Stickers with assigned spot number on trailer assigned to said spot. Stickers must be visible from RV Storage aisle for inspections.
